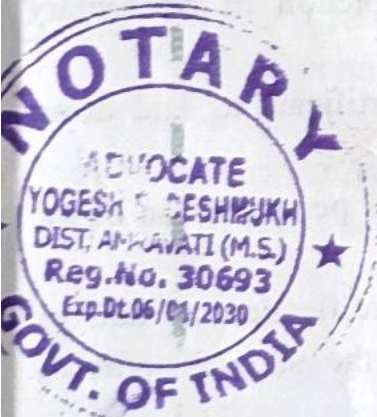

Subject : To the provisions of the Maharashtra to free and Compulsory Education Rules 2011 made under the Right of Children to free and Compulsory Education Act 2009. The certificate of Recognition hereby grant to the Manager/Principal of Abhyasa English School Rewsa situated at Rewsa Road Amravati 444801 for classes 1 to 8 for three years from 1 April 2019 to March 2022

CONDITIONS:

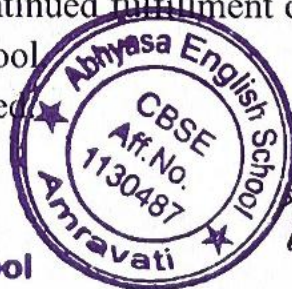
1. The grant for recognition is not extendable and does not in any way imply any obligation to recognize /affiliate beyond.
2. The school shall abide by the provisions of Right of Children to Free and Compulsory education rules, 2011 the guidance by the Government of India and the State Government and any instructions, directions or Government Resolutions.
3. The School shall admit in Class / including pre-primary classes, to the extent of 25 % of the strength of that class, children belonging weaker section and disadvantage group in neighborhood and provide free and compulsory elementary education till its completion.
4. Taking capitation is prohibited and therefore the trust society or school shall collect any capitation fee or anyway other donation or articles in lieu such a fees.
5. The school shall not adopt in anyway any screening test or procedure of the child or his or her parents or guardians for the purpose of admission.
6. The school shall not deny admission to any child for lack of age proof or on ground religion, caste, creed or race, place of birth or any of them.
7. The school shall ensure that:
 - i) No child admitted shall be held back in any class or expelled from school till completion of elementary education in a school.
 - ii) No child shall be subjected to physical punishment or mental harassment.
 - iii) No child is required to pass any board examination till the completion of elementary education.
 - iv) Every child completing elementary education shall be awarded a certificate as laid down under Rule 30.
 - v) The students with disability of special needs are admitted /included as per provision of the act.
 - vi) a) The teachers are required having and fulfilling the minimum qualification as laid by National Council of Teachers education and state government or the such a authority authorized under sub-section(1) of section 23 of the act.
b) Also see that the qualifications prescribed by the government resolution, education No. PRE-1100-223-K dated the 27 April 2011 is complied with;
c) The existing teachers who at the commencement of this act do not possess minimum qualification shall acquire such a minimum qualification within a period of five years from commencement of the act.
d) Any new teacher who is recruited after the publication of the government education department No. PRE-1110-223-K dated 27 April 2011 shall be required to pass the prescribed teachers eligibility test (TET) of respective group.
 - vii) The order shall adhere to students-teachers ratio prescribed in the schedule to the act or, as the case may be. The ratio prescribed by clause (d) of sub rule (1) of rule -13 if school has class room lesser size than 100 sq feet, whichever is less. The recruitment of the teachers shall be in accordance with the requirement specified in the schedule.

- viii) The rules governing the salary and allowances payable to and the term and conditions of service of teachers made by the state government shall apply.
- ix) The teachers perform its duties as specified under sub-section (1) of section-24 of the act.
- x) The teachers shall not engage him or her private teaching activities.
- xi) Any regulation, direction, instruction or guidelines issued from time to time by the State Government or the Director of the Primary Education with regards to the fees to be charged from the students shall be strictly followed..
8. The school shall impart education as per the syllabus prepared on basis of curriculum laid down by appropriate authority.
9. The school shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the act.
10. The school shall maintain the students and norms of the school as specified in section 19 of the act and comply with all the conditions of Rule 13 particularly those pertaining to furnishing of any information, maintenance of website of the school and filling DISE data correctly and truthfully every year within stipulated time.
11. No unrecognized classes shall be run within the premises of the school or outside in the same name of school.
12. The school building or other structures or the grounds are used only for the purposes education and skill development.
13. The school is run by a society registered under the Societies Regulation Act, 1860 (21 of 1860), or a public trust constituted under any law for the time being in force.
14. The school is not run for profit to any individual, group or association of individuals or any other persons.
15. The accounts shall be audited and certified by a Chartered Accountant and proper Accounts statements shall be prepared as per rules. A copy of the audited report with all statement of accounts shall be sent to the Competent Authority every year.
16. The recognition code number allotted to your school 27070203403 .This may please be noted and quoted for any correspondence with this office.
17. The school shall furnishes such reports and information as may be required by the Director and the competent Authority from time to time and complies with such instructions of the state Government /Local Authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
